<b>List 3 main reasons for your views either for or against Question 1 of the proposal.</b>	
Reason 1	Our Parent Council asked this question directly in our Consultation of the Parent Forum at Sgoil Ghàidhlig Ghlaschu. Only 16.2% of respondents explicitly supported the Gowanbank option. There were a number of reasons given which are summarised in the comments submitted by respondents (attached) as to why Gowanbank was not suitable to a majority when asked directly.
Reason 2	Following on from Reason 1, however, 31.5% of respondents indicated no preference on the siting of new provision (given the options of Gowanbank and Cartvale). When asked directly to indicate a preference, 33.3% of respondents supported Cartvale as an option. The reasons for these preferences are indicated in the comments submitted by respondents (attached).

**List 3 main reasons for your views either for or against on Question 2 of the proposal.**

Reason 1

Asking the binary option question of "Are catchments appropriate or not", indicated that 40.4% of respondents thought the catchments were appropriate and 37.6% thought the catchments were not appropriate. However, we offered respondents a third option in our consultation with the Parent Forum – to submit "alternative options" as a way of gathering different views. When "alternative options" – an implicit rejection of the "catchments are appropriate" option – and the "catchments are not appropriate" option are considered together, they represent 59.6% of respondents. Therefore, we cannot agree with the catchments areas as set out in the consultation document. A strong theme that emerged from the comments submitted by respondents was that the inclusion of an area North of the River Clyde was not appropriate for the Gowanbank option for a myriad of reasons as outlined in the comments submitted by respondents (attached).
